**THE COUNTY OF PEMBROKE (ST MICHAELMAS FAIR) (MAIN STREET,
PEMBROKE)**
(TEMPORARY TRAFFIC RESTRICTION & SUSPENSION) ORDER 2018

NOTICE is hereby given that the Pembrokeshire County Council has made the following Order under Section 21 of the Town Police Clauses Act 1847 for the prevention of obstruction etc.

WHEREAS during certain hours on Wednesday 10th, Thursday 11th, Friday 12th, Saturday 13th and Sunday 14th October 2018, due to a Fair taking place, Main Street, Pembroke will be thronged and liable to be obstructed.

Pembrokeshire County Council pursuant to the powers conferred by Section 21 of the Town Police Clauses Act 1847 **DO HEREBY ORDER AND DIRECT** that for the purpose of preventing obstruction in the said Street on the said days, the following regulations shall be observed:-

1. Subject to those provisions contained in article 3, Main Street, Pembroke shall be closed to all vehicular traffic including pedal cycles on **Wednesday 10th October, 2018**, between 13:00hrs and 22:00hrs for the safe construction of the fair and **Sunday 14th October, 2018**, between 06:00hrs and 10:30hrs for the dismantling of the fair.
2. Subject to those provisions contained in article 4, Main Street, Pembroke shall be closed to all vehicular traffic including pedal cycles during the opening hours of the fair which are:-

18:00hrs to 23:45hrs on Thursday 11th October 2018
18:00hrs to 23:45hrs on Friday 12th October 2018
14:00hrs to 23:59hrs on Saturday 13th October 2018
3. Nothing in article 1 shall apply to any vehicle being used by the emergency services, access for residents, or those vehicles being used in connection with the setting up or removal of the fair.
4. Nothing in article 2 shall apply to any vehicle being used by the emergency services or anything done with the permission or under the direction of a Police Officer.
5. Drivers of vehicles approaching Main Street from Mill Bridge and wishing to proceed in an easterly direction along Main Street to East End Square shall be diverted via Castle Terrace, Westgate Hill, Common Road, Orange Way and Well Hill.
6. Drivers of vehicles approaching Westgate Hill from Monkton Bridge and wishing to proceed in an easterly direction along Main Street to East End Square shall be diverted via Common Road, Orange Way and Well Hill.
7. The one way order for Goose's Lane will be temporarily suspended for the duration of the closures to enable two way access to properties along its length.

Yn amodol ar y darpariaethau sydd yn erthygl 3, bydd y Stryd Fawr, Penfro, wedi ei chau i bob traffig cerbydol yn cynnwys beiciau pedalau **dydd Mercher y 10^{fed} Hydref 2018**, rhwng yr amserau 13:00 a 22:00 er mwyn gallu codi'r ffair yn ddiogel a dydd **Sul y 14^{eg} Hydref, 2018** rhwng yr amserau 06:00 a 10:30, er mwyn tynnu'r ffair i lawr.
2. Yn amodol ar y darpariaethau hynny sydd yn erthygl 4, bydd y Stryd Fawr, Penfro, wedi ei chau i bob traffig cerbydol yn cynnwys beiciau pedalau yn ystod yr oriau y bydd y ffair yn agored, sef:-

18:00 tan 23:45 dydd Gwener y 12^{eg} Hydref 2018
14:00 tan 23:59 dydd Sadwrn y 13^{fed} Hydref 2018

9. Ni fydd dim yn erthygl 2 yn berthnasol i unrhyw gerbyd y mae'r gwasanaethau brys yn ei ddefnyddio nac i unrhyw beth a wneir gyda chaniatâd neu gyfarwyddyd Swyddog o'r Heddlu.
10. Bydd gyrwyr cerbydau sy'n dod at y Stryd Fawr o Mill Bridge ac eisiau mynd ymlaen tua'r dwyrain ar hyd y Stryd Fawr i East End Square yn cael eu troi drwy Castle Terrace, Westgate Hill, Common Road, Orange Way a Well Hill.
11. Bydd gyrwyr cerbydau sy'n dod at Westgate Hill o Bont Cilmaen ac eisiau mynd ymlaen tua'r dwyrain ar hyd y Stryd Fawr i East End Square yn cael eu troi drwy Common Road, Orange Way a Well Hill.
7. Bydd y gorchymyn un ffordd ar gyfer Goose's Lane yn cael ei atal am hyd y cau er mwyn galluogi mynediad dwy ffordd i eiddo ar ei hyd
